## **RE: CALL FOR NOMINATION FOR ELECTIONS FOR THE YEAR 2024**

In line with RELI REGULATED N-DT SACCO by-laws clause 20.2 which so states; There shall be a Nominating Committee of the SACCO Society which shall be constituted in accordance with the SACCO Society's Electoral Policy, which shall be formulated by the Board of Directors to vet and clear the prospective candidates for elections,

The board wishes to inform and notify all interested and prospective candidates from our Sacco branches of the various delegate's positions at the branches. The Board has formulated the electoral policy and the elections of all officials in the branches and in the Board for the year 2024 will be conducted in accordance with the Reli Regulated N-DT Sacco Electoral policy in place, the Sacco by- laws and regulations 2020 in place.

The interested candidates are hereby invited to pick the nomination forms and are requested to contact the office of the CEO via 0727 796 323 or liase with their branch officials for more information on how to get the nomination forms. The Board want to inform you that after filling and attaching the mandatory certificates same should be returned **on/or before 30**<sup>th</sup> **January 2024**. No form shall be received after the closure date. The vetting exercise will begin thereafter.

Candidates who have been vetted and cleared by the nomination and vetting Committee will be notified through any of the following: emails, letters and SMS. Branch elections will thereafter be scheduled and conducted after an official notification through circulars after through consultation with the Ministry.

The following are the requirements for a member who qualifies to be a delegate.

- 1. Must be cleared by the vetting committee to vie for a delegate post of Reli Sacco branches and must be 18 years and above.
- 2. Must be an active member for at least six consecutive months.
- 3. Must have attained a minimum of form four level of education.
- 4. Should not be a person with un-discharged bankruptcy;
- 5. Should be of sound mind.
- 6. Has not been adversely named by the Commissioner or the Authority in an inquiry report adopted by a Delegates Meeting for mismanagement or corrupt practices while serving as member of the Board of Directors.
- 7. Has not been convicted of any offence involving dishonesty dealings with the Sacco members, convicted of any other offence under Act or Rules or has been sentenced to imprisonment for a term exceeding three months.
- 8. Should not be a person against whom any amount of money is due under a decree, decision or order or is pending recovery under the co-operative society Act;
- Should have attained minimum deposits of Kshs. 250,000 and minimum share capital of ksh. 20,000 per the by-laws and/or as will be prescribed by the Board and approved by the ADM from time to time, at least 2 months prior to election date for a delegate post.
- 10. Should have made loans payment due to the society in time and not a defaulter.
- 11.Is not an official of or holds a political office of any level
- 12. Has not been removed from any public office on displinary action.
- 13.He/she does not instigate or has not been found instigating Negative publicity against the Society .:

The electoral policy is already in place with the branch official and prospective candidates are requested to go through the document to acquaint themselves with the various requirement of the same.
